Course Name: OSHA 10 hour and 30 Hour Construction Outreach Training

## Course Overview:

OSHA recommends Outreach Training Program courses as an orientation to occupational safety and health for workers. Workers must receive additional training, when required by OSHA standards, on the specific hazards of their job.

**Course Length:** Minimum of 40 hours. This course is an online, interactive program which can be taken at the student's pace and convenience. It is available online 24/7 and will be an active, available program for six months from the date of registration.

## **Course Content:**

The successful completion of this course will help to meet the Construction Industry standards established by OSHA.

Module covers thirty (30) hours of courses, required by the Occupational Health and Safety Act (OSHA), that apply toward 30-hour Construction Industry course completion card. This module is comprised of 23 sections, each either one or two hours in length, and covering topics pertaining to regulations covered by Standard 29 CFR 1926. The successful completion of this course will help to meet the Construction Industry standards established by OSHA.

You will be sent a copy of OSHA Standards for Construction. The book will serve as an invaluable resource for referencing OSHA standards that have been covered in this course, as well as researching regulations or standards that could help in establishing a safer workplace.

You will also find supplementary materials available for download by clicking the ""Materials"" tab on the menu located within the courseplayer. You can find printable course summaries of each module in addition to a syllabus of the entire 30 hour course.
